Previously, trading of Crude Palm Oil type A or CPOA, palm oil refinery for Crude Palm Oil type B or CPOB, and trading of CPOB

Now, both companies have been ceasing the CPOA trading business since October 1, 2018 and have completed the Company's amendment registration to carve out the CPOA business since October 12, 2018
