According to the resolution of the Board of Directors of Ocean Commerce Public Company Limited No. 3/2019 held on February 27, 2019, it was resolved to approve the financial statements and operating results of the Company for the year ended 31 December 2018, which has been audited by the auditor With significant operational results as follows

The operating results of the Company for the year ended 31 December 2018 showed a net loss of Baht 147.00 million, compared with the operating results of the same period of 2017, with a net loss of Baht 31.24 million. The work decreased by amount (115.76) million baht or (370.55) percent caused by the following reasons:

Revenue from sales and services - faucet and plumbing business Of the company increased from 292.12 million baht to 308.09 million baht in the amount of 15.97 million baht or 5.47 percent as a result of the company adjusting the marketing policy to expand the market share by adjusting the sales price decreased And increased trade discounts To increase sales volume and bring new products to open more markets Thus increasing the revenue from sales and services of the company this year Details are as follows


