BPS Technology Public Company Limited ("the Company") would like to notify that SME Trust (Sub-Fund 2) (holding 54,193,548 shares or 13.55 percent of total shares) and Mr Rutchchayuth Jerapornprapa (holding 29,416,800 shares or 7.35 percent of total shares) has totally sold their shares on April 3, 2024. The details of relevant shareholding structure of the Company after the transaction are as follows:

The Company would like to clarify that SME Trust (Sub-Fund 2) and Mr Rutchchayuth Jerapornprapa were not a person involved in the management of the company. The cause of changing in shareholding structure is the case was that the shareholders sold their shares on the Market for Alternative Investment (MAI). Meanwhile, the shares held by the group of Mr. Surapong Saretchapan and Ms. Pattaraporn Kaewpoca (the two groups of "major shareholders" accounting for 56.45 percent of the total shares were still be in Silent Period according to the criteria of the Stock Exchange, and with voluntarily (after IPO, trading will be prohibited for 1 year from the first day trading, 25 percent of those shares can be sold after 6 months and all of the shares can be sold after 1 year) as disclosed in the company's filing form. Therefore, the major shareholders still being the management of the Company and the Company has no plans to change the core business operations or management structure of the Company.
